Roberta M. Jaffe

Farmer Activist | Condor's Hope Vineyard, Cuyama Valley Small Farmer & Rancher Network, Cuyama Valley Community Association

Roberta (Robbie) Jaffe has been engaged in developing healthy and just food systems since the 1970's. For the past 32 years Robbie and her husband, Steve Gliessman, have developed their organic, dry farmed vineyard and olive orchard, Condor's Hope, in the Cuyama Valley, one of California's 21 critically overdrafted groundwater basins.

As a farmer activist Robbie is a voice for small pumpers, the community and local ecosystems in the development of Cuyama's Groundwater Sustainability Plan. She has served on the Standing Advisory Committee to the Cuyama Basin Groundwater Sustainability Agency since 2017.

Through collaboration with the community, she has been a local leader in Cuyama Valley groundwater issues including: successfully opposing basin boundary modifications to DWR; successfully opposing county permitting of large reservoirs to be filled with groundwater; and building networks in the Cuyama Valley to develop a sustainable groundwater basin and a local food system.



Katrina B. Mitchell, MD

Breast surgeon, lactation consultant, and perinatal mental health provider | Sansum/Sutter Health

Katrina B. Mitchell, MD, IBCLC, PMH-C is a breast surgeon, lactation consultant, and perinatal mental health provider at Sutter Health in Santa Barbara, CA.

She was born and raised in California's agricultural central valley, then graduated Phi Beta Cappa with highest honors in history from Bowdoin College in coastal Maine. She received the most outstanding honors thesis award for her investigation into the forced sterilization of Native American women in the 1970s.

After college, she worked at reproductive health clinic in urban Philadelphia and fell in love with women's health. She subsequently graduated from Dartmouth Medical School and began general surgery residency at Cornell-New York Presbyterian Hospital in New York, New York. During this time, she was a global health scholar and worked with several surgical and infectious disease projects at Cornell's partner hospital in Mwanza, Tanzania-East Africa, most notably female urogenital schistosomiasis. Locally, she is an advocate for improving women's healthcare throughout the central coast.
